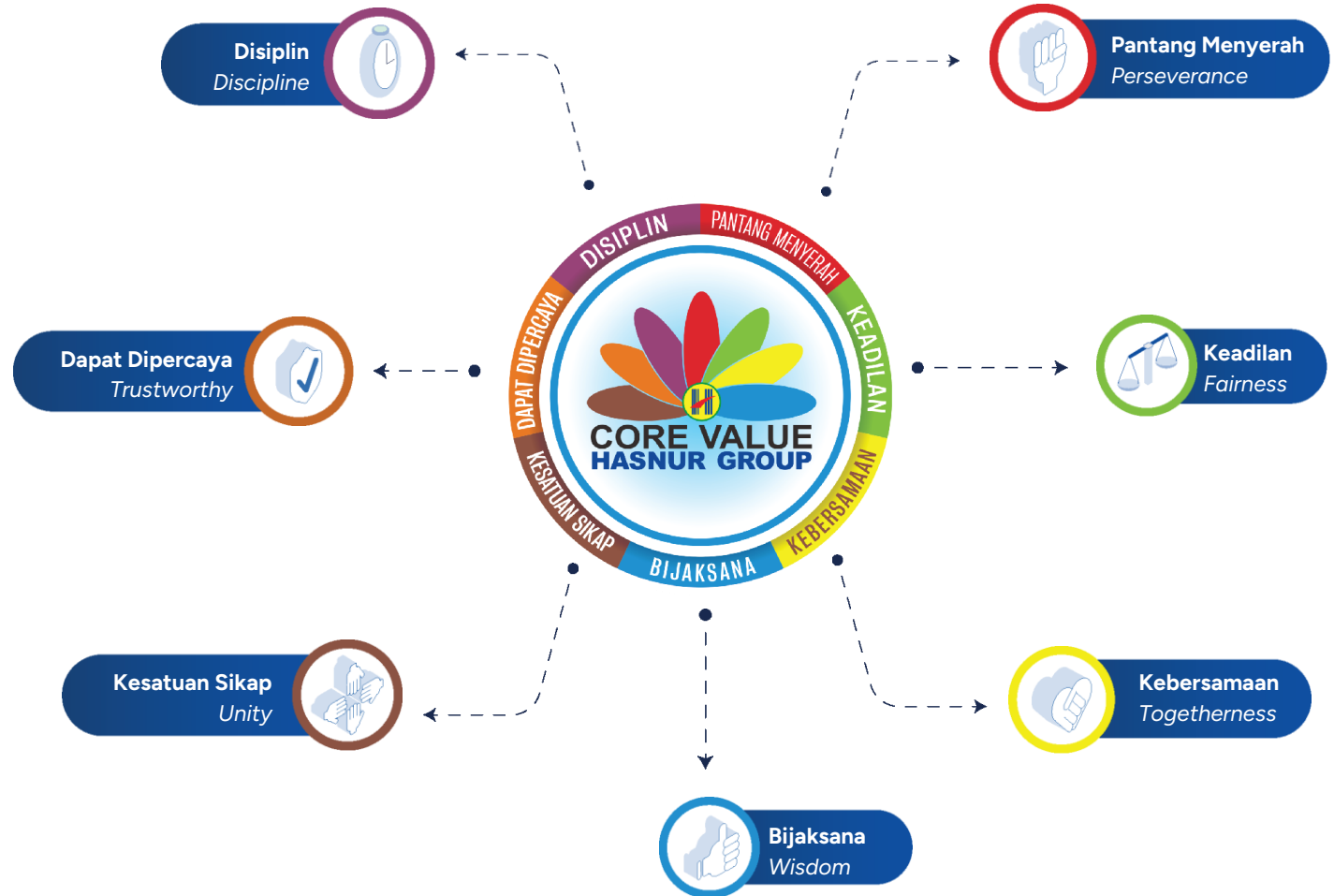

The Company was first established under the name PT Hasnur Internasional Shipping (HIS) on December 14, 2009;

• **Pendirian Entitas Anak, yaitu PT Hasnur Mitra Sarana.**
Establishment of a Subsidiary, namely PT Hasnur Mitra Sarana.

2010

• **Perseroan melakukan kegiatan pelayaran komersial pertamanya pada 24 Oktober 2010.**
The Company carried out its first commercial shipping activity on October 24, 2010.

2011

• **Perseroan mulai melayani pelayaran batu setelah batu bara.**
The company began providing stone transportation services other than coal.

• **Pendirian Entitas Anak, yaitu PT Hasnur Resources Terminal.**
Establishment of a Subsidiary, namely PT Hasnur Resources Terminal.

2013

• **Pengoperasian armada kapal tunda (tugboat) dan tongkang (barge) untuk mengangkut komoditas lain selain batu bara seperti CPO, gypsum, batu split, dan lain-lain.**
